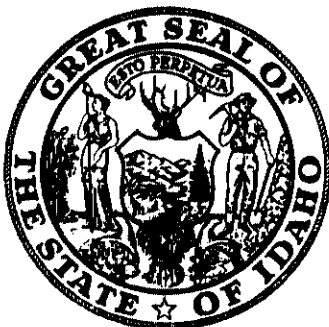
### CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

FIRST

The name of the corporation is JOE FREIBURGER FARMS, INC.,

SECOND

The purpose of the corporation is to engage in the business of farming, including the purchase, sale, mortgage, pledge, assignment, transfer of real and personal property, and all other lawful acts in furtherance of the purposes of said corporation.

THIRD



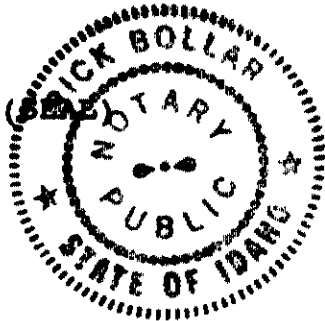
