

Articles of Incorporation

of the

Weiser Drug Company, Limited.

We, the undersigned, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the laws of the state of Idaho, do hereby certify as follows:

1. The name of the corporation is

Weiser Drug Company, Limited.

2. The objects for which the corporation is formed are:

To own, maintain, and conduct a general retail and wholesale drug store and drug business.

To buy and sell, at retail and wholesale, or otherwise to deal or to traffic in drugs, medicines, and other articles of merchandise generally found in a first-class drug store.

To buy and sell, to lease or incumber, either personal property or real estate, for any purpose of the company whatever.

3. The principal place of business of the corporation is at Weiser, in the county of Washington, state of Idaho.

4. The duration of the corporation shall be fifty years.

5. The business of the corporation shall be managed by a board of three directors.

6. The total authorized capital stock of the corporation is Ten Thousand Dollars (\$10,000.00), divided into one hundred shares of the par value of One Hundred Dollars (\$100.00) each.

7. The names and post-office addresses of the incorporators, and the number of shares of stock for which severally and respectively we do hereby subscribe (the aggregate of our said

subscriptions being Four Thousand Five Hundred Dollars (\$4500.00) is the amount of capital stock with which the corporation will commence business), are as follows:
