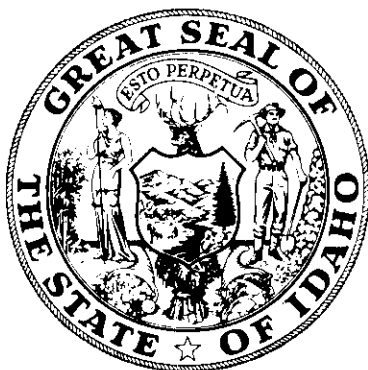

The undersigned, in order to form a corporation pursuant to the Idaho Business Corporation Act, certify as follows:

ARTICLE I  
BASIC STRUCTURE

1.1 Name. The name of the corporation is Smith-Chadez Masonry Inc. ("Corporation").

1.2 Purpose. The purposes for which this Corporation is organized are as follows:

- a. To engage in the business of masonry contracting; and
- b. To engage in any other lawful activity for which corporations may be incorporated under the Idaho Business Corporation Act.

1.3 Existence. The Corporation shall have perpetual existence.

1.4 Registered Office and Agent. The address of the initial registered office of the Corporation shall be 1035 Fair Lane, Nampa, Idaho 83651. The name of the Corporation's initial registered agent at such address is Paul Smith.

ARTICLE II  
COMMON SHARES

The Corporation is authorized to issue 50,000 Common Shares, each having a par value of \$1.00 per share. The Common Shares shall have the same rights in the Corporation and shall be non-assessable when paid in full.

The names and addresses of the incorporators, who have named themselves as the initial directors to serve until the first election of directors of the Corporation, are as follows:



The Corporation reserves the right to amend, alter, change, or repeal any provisions contained in these Articles of Incorporation in the manner now or hereafter prescribed by law.


