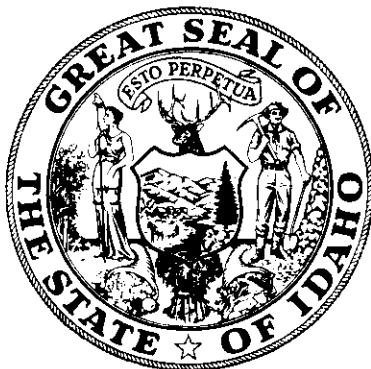

ARTICLE I. NAME

The name of this corporation is EDWARD A. LAWSON, P.A.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSES

The purpose of this corporation is to render legal or allied professional services to the public.

ARTICLE IV. CAPITALIZATION


