

ARTICLES OF INCORPORATION OF THE SUMMIT TRAMWAY  
COMPANY, LIMITED.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned residents and freeholders of Nez Perce County, State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a Corporation, under the laws of the State of Idaho.

And we hereby certify: First. That the name of said Corporation is The Summit Tramway Company, Limited.

Second. That the purposes for which it is formed are to build, operate erect, construct and maintain a cable tramway across the Clearwater River, commencing at a point about 200 feet east of the northwest corner of the northwest quarter of the southeast quarter of Section ten (10) in Township thirty-six (36) north of range two (2) west, B.M., within said northwest quarter of the southeast quarter of said section ten (10), and extending on a straight line across the Clearwater River to a point on the north side of the Clearwater Branch of the Northern Pacific Railway Company, about midway, east and west, of Lot three (3) of Section Thirty-four (34), Township thirty-seven (37) north of range two (2) west, B.M., in Nez Perce County, State of Idaho, and to build, construct, maintain and operate other cable tramways across the said Clearwater River in said Nez Perce County, when the business of said Corporation will justify or demand additional cable tramways, to build, construct, operate and maintain warehouses for the storage of goods and grain at, on and along the site of said tramway, and at each end thereof, to buy, sell, handle, store, transfer and transport grain, hay and produce, to handle and transport goods, wares and merchandise from one side of the Clearwater River to the other by means of said cable tramway, and to store grain, goods, wares and merchandise in the

warehouses of said Company, and to do a general tramway business; also to purchase, hold and convey such real and personal estate as the purposes of the incorporation may require, and to purchase, condemn and secure rights of way necessary for the erection, construction maintaining, and operating of said cable tram way or any cable tramway which said Corporation may erect, construct, maintain and operate across the Clearwater River in said Nez Perce County.

Third. That the place where its principal business is to be transacted shall be the town of Summit, County of Nez Perce, State of Idaho.

Fourth. That the term for which it is to exist is fifty years from and after the date of its incorporation. ✓

Fifth. That the number of its directors shall be seven, and that the names and residences of those who are appointed for the first year are:

Sixth. That the amount of the capital stock of this Corporation shall be Twenty-five Thousand (25,000) Dollars, divided into two hundred and fifty ( 250 ) shares of the par value of One Hundred (100) Dollars each. ✓
