ARTICLES OF INCORPORATION
OF

KNOW ALL MEN BY THEIR PRESENCE:

That we, the undersigned being all adult citizens of the United States and citizens and residents of the State of Idaho, for the purpose of forming a nonprofit corporation under the provisions of Title 30 of the Idaho Code, do hereby adopt the following Articles of Incorporation:

I.

The name of this corporation shall be North Idaho Citizens for Decency, Inc.

II.

The corporation shall be a nonprofit corporation.

III.

The duration of the corporation shall be perpetual.

IV.

The purpose of the corporation is to educate the people of our community as to the harmful effects of pornography, obscenities and indecency on children, families; to eradicate these harmful influences from our communities.

V.

The corporation shall have members and the management of its affairs is to be vested in its board of directors pursuant to Section 30-314(a) Idaho Code.

VI.

The initial registered office of the corporation shall be 1924 Front Street, Coeur d'Alene, Idaho, and the initial registered agent shall be Teresa Sheldon.

VII.

The incorporator is Teresa Sheldon, P. O. Box 2072, Coeur d'Alene, ID 83814.

VIII.

The Board of Directors consisting of 5 to 11 members shall be elected by the membership. The maximum term of office shall be 3 years and the terms of the directors shall be staggered so that, as much as possible, one-third of the directors will be elected each year.

IX.

The fiscal year of the corporation shall be May 31.

X.

The corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future code.

XI.


No part of the earnings of the corporation shall enure to the benefit of, or benefit of, or administered to its members, directors, officers, or other private persons except that the treasurer shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above.

XII.

No substantial part of the activities of this organization shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the organization shall not participate or intervene in any political campaign on behalf of any candidate from public office.

XIII.

Upon dissolution of the organization assets shall be distributed for one or more purposes within the meaning of Section 501(c)(3) of the Internal Revenue or corresponding section of any future federal tax code or shall be distributed to the federal government or to a state or local government for public purpose.
