

Dear Mr. Johnson:

The Idaho Department of Finance (Department) received your letter dated September 9, 2022, providing written notice of Northpointe Bank's intent to open a Loan Production Office (LPO) at 12403 S. Sunrise Mist Loop, Nampa, Idaho. Two additional LPOs located at 104 W Warner Rd., Post Falls, Idaho, and 9094 N Finucane Dr., Hayden, Idaho, were identified through email correspondence on September 30, 2022, as Northpointe Bank employees will be conducting at least one of the activities listed in Idaho Code § 26-302 from those locations.

The information provided satisfies the requirements of Idaho Code § 26-302. The Department has no objection to the establishment of the three LPOs at 12403 S Sunrise Mist Loop, Nampa, Idaho, 104 W Warner Rd., Post Falls, Idaho, and 9094 N Finucane Dr., Hayden, Idaho, for activities specifically listed under § 26-302. The Department has not approved the LPOs to accept deposits or disburse funds.

Please note Idaho Code § 26-302(3) requires a bank to give notice to the Department at least 30 days prior to opening the LPO, and § 26-302(4) requires notice of any relocation or closure of the office, including the date of the relocation or closure and the disposition of any records previously maintained at the LPO.
