That we, the undersigned, being natural persons, of full age and citizenship of the United States, and of the State of Idaho, in order to form a corporation for the purposes hereinafter stated, pursuant to the statutes of the State of Idaho, do hereby certify as follows:

1.

That the name of the Corporation is Garner Flying Service, Inc.

2.

The purpose for which said Corporation is formed is to acquire by purchase, various types of airplanes, and to hold the titles to the airplanes in the name of the Corporation, to buy and sell airplanes, and airplane parts, to sell and offer to sell various tupes of airplanes, to use airplanes for charter flights and for crop dusting, and any and all other allied businesses connected with the operation of flying business.

That the Corporation is to have existence for a period of 50 years.
