sociated ourselves together for the purpose of forming a cor-
poration, under the laws of the State of Idaho.

AND WE HEREBY CERTIFY: First; That the name of said
Corporation is the Sunnyside Gold and Silver Mining Company.

ry on the business of mining, milling, reduction and treating
