AMENDMENT TO ARTICLES OF INCORPORATION TO

The name of the corporation is Life Center Alumni Association, Inc.

2. Article III of the Articles of Incorporation is amended to read as follows:

This organization is organized exclusively for charitable and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. specific and primary charitable purposes for which this nonprofit corporation is formed are: to act as a coordinating, educational, fundraising and service organization to foster, promote, encourage and increase the knowledge, and understanding of and the availability of treatment for people with alcohol and drug addictions or related problems. This corporation shall essentially direct its services and functions toward the people of the State of Idaho, but may extend its services and opportunities to all who otherwise qualify. No part of any net earnings shall inure to the benefit of any private member, except that said nonprofit corporation shall not be precluded from disbursing its funds in the form of awards, grants, loans, etc., to any person its Board of Directors shall deem advisable.

- 3. Article X d. of the Articles of Incorporation is amended to read as follows:
 - d. To have and to exercise all the powers conferred by the laws of the State of Idaho upon corporations and nonprofit corporations formed under the laws of this State, and pursuant to and under which this nonprofit corporation is formed, as such laws are now in effect, or may at any time hereafter be amended. Northwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (or the

corresponding provision of any future United States Interal Revenue Law.

- 4. Article X h. of the Articles of Incorporation is amended to read as follows:
 - h. Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable, educational, religious and/or scientific purposes and which has established its tax exempt status under section 501(c)(3) of the Internal Revenue Code.
- 5. These amendments to the Articles of Incorporation were adopted by a consent in writing signed by all members entitled to vote with respect thereto.
