KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, in order to form a corporation for the purposes hereinafter stated, pursuant to the Idaho Business Corporation Act, as now in effect or as may hereafter be amen do hereby certify as follows:

> ARTICLE I The name of this coporation shall be Idaho Mortgage Brokers, inc.

ARTICLE II The period of duration of this corporation shall be perpetual.
