ARTICLES OF AMENDMENT

OF

JOHNSON-FEED LOT, INC.

KNOW ALL MEN BY THESE PRESENTS, That JOHNSON FEED LOT, INC., a corporation organized under the laws of the State of Idaho, by action of the Board of Directors and Stockholders as provided by law does hereby certify that the Articles of Incorporation of said corporation be amended as follows:

ARTICLE I

NAME

The name of this corporation shall be JOHNSON-FALEN CATTLE CO., INC.

ARTICLE V

STOCK

This corporation is authorized to issue one class of capital stock which shall be designated as common stock. The total number of shares of common stock this corporation shall be authorized to issue is 2,500 shares. The par value of the common stock shall be \$100.00 per share. The aggregate par value of this common stock shall be \$250,000.00.

The entire voting power of the corporation shall be vested in the holders of common stock and every stockholder of record shall have the right, at every shareholders' meeting, to one vote for every share of common stock standing in his name on the books of the corporation.

The capital stock of this corporation shall be non-assessable, and the private property of the shareholders of this corporation shall not be liable for the debts, obligations and liabilities of this corporation.
