ARTICLES OF INCORPORATION

OF

SECUERT BROTHERS DAIRY, INC.

KNOW ALL MEN BY THESE PRESENTS, that we the undersioned, the United States, have this day voluntarily associated ourselves for the purpose of forming a private corporation under the laws of the State of Idaho, and to that end hereby adopt Articles of Incorporation as follows:

ARTICLE I

NAME

The name of the corporation is Seubert Brothers Dairy, Inc.

ARTICLE II

PURPOSE

The purposes of the corporation are to do any or all things herein mentioned as fully and to the same extent as natural persons might or could do, and in any part of the world, viz:

1. To carry on and conduct the production, transportation and merchandising of farm, dairy and related products, deal in and with property of every kind and character, real, personal or mixed, tangible or intangible, wherever situated and however held, including, but not limited to, money, credits, choses in action, securities, stocks, bonds, warrants, script, certificates, debentures, mortgages, notes, commercial paper and other obligations and evidences of interest or in indebtedness of any person, firm or corporation, foreign or domestic, or of any

government or subdivision or agency thereof, documents of title, and accompanying rights and every other kind and character of personal property, real property (improved or unimproved), and the products and availas thereof and every character of interest therein and appurtenance thereof, including but not limited to, mineral, oil, gas and water rights, all or any part of any going business and its incidents, franchises, subsidies, charters, concessions, grants, rights, powers, or privileges, granted or conferred by any government or subdivision or agency thereof, and any interest in or part of any of the foregoing, and to exercise in respect thereof all of the rights, powers, privileges, and immunities of individual owners or holders thereof.

- 2. To hire and employ agents, servants and employees, and to enter into agreements of employment and collective bargaining agreements, and to act as agent, contractor, trustee, factor or otherwise, either alone or in company with others.
- 3. To promote or aid in any manner financially or otherwise, any person, firm, association or corporation, and to guarantee contracts and other obligations.
- 4. To let concessions to others to do any of the things that this corporation is empowered to do, and to enter into, make, perform and carry out, contracts, arrangements of every kind and character with any person, firm, association or corporation, or any government or authority or subdivision or agency thereof.

5. To carry on any business whatsoever that this corporation my deem proper or convenient in connection with any of the foregoing purposes or otherwise, or that it may deem calculated, directly or indirectly, to improve the interests of this corporation, and to do all things and to exercise all powers conferred by the laws of the State of Idaho on corporations formed under the laws pursuant to which and under which this corporation is formed, as such laws are now in effect or may at any time hereafter be amended, and to do any and all things hereinabove set forth to the same extent and as fully as natural persons might or could do, either alone or in connection with other persons, firms, associations or corporations, and in any part of the world.

The foregoing statement of purposes shall be construed as a statement of both purposes and powers, shall be liberally construed in aid of the powers of this corporation, and the powers and purposes stated in each clause shall, except where otherwise stated, be in no ways limited or restricted by any term or provision of any other clause, and shall be regarded not only as independent purposes, but the purposes and powers stated shall be construed distributively as each object expresses, and the enumeration as to specific powers shall not be construed to limit in any manner the aforesaid general powers, but are in furtherance of, and in addition to and not in limitation of said general powers.

The primary business functions of the corporation will be the production of farm and dairy products.

ARTICLE III

DURATION

The duration of this corporation is perpetual.

ARTICLE IV

LOCATION

ARTICLE V

STOCK

The total authorized number of par value shares of stock is not more than 250. The aggregate par value of the total authorized number of par value shares is TWO THOUSAND FIVE HUNDRED (\$2,500.00) DOLLARS. The total authorized number of shares without par value is none.

The stock of the corporation is divided into 250 shares of common stock, at a par value of \$10.00 per share. The shares of stock of the corporation shall not be subject to assessment.
