### ARTICLES OF INCORPORATION

OF

## M & D ENTERPRISES, INC.

We, the undersigned natural persons all over the age of twenty-one years and citizens of the United States acting as incorporators under the Idaho Corporation Laws, adopt the following Articles of Incorporation:

#### ARTICLE I.

The name of this corporation is M & D ENTERPRISES, INC.; its duration shall be perpetual.

#### ARTICLE II.

The purposes of the corporation are as follows:

- (a) To buy and sell, export, import, lease, exchange and generally deal in machinery and equipment of all kinds and descriptions and to act as agent for others for all or any of said purposes and to acquire by purchase, lease or otherwise, to equip, maintain and operate machine shops and foundries for the manufacture of automotive equipment and machines of all makes, types and kinds and to develop, originate and invent mobile machines of various types and kinds, and to sell and promote the sale of all such kinds and every kind of machines and equipment, both at retail, wholesale and otherwise.
- (b) To engage in the sale and distribution on a world-wide basis of automobiles and all other vehicles for use in transportation and in particular, but not limited to, the manufacture, ownership, sale and distribution of automotive vehicles capable

of traveling through snow, mud, water or any other inhospitable terrain and to own, hold and acquire patent rights for such vehicles or all similar or related types of machines and vehicles.

- (c) To build, erect, construct, lease or otherwise acquire, manage, occupy, maintain and operate, buildings for commercial purposes and for dwelling houses, apartment houses, office buildings and to purchase, acquire, through issuance of its capital stock or otherwise, to own, hold, lease, either as lessor or lessee, sell, exchange, subdivide, mortgage, operate and generally deal in any and all kinds of lands, improved and unimproved, dwelling houses, apartment houses, hotels, commercial houses of all types, manufacturing works and plants and any and all other buildings and structures of any kind.
- (d) To subscribe for, acquire by purchase or otherwise, and to hold, own, sell, assign and transfer shares of the capital stock of this or any other corporation and to exercise all the rights of a stockholder, to acquire by purchase or otherwise hold and dispose of the stocks and bonds of this or any other corporation.
- (e) To engage in any business whatsoever, either as principal or as agent or as both, or the syndicate which the corporation may deem convenient or proper in the furtherance of any of the purposes hereinabove mentioned, or otherwise; and to conduct its own business in this state, in other states of the United States, in the District of Columbia, and in foreign countries, and to have and to exercise all the powers authorized by the laws of the State of Idaho under which this corporation is formed, whether expressly set forth in this Article or not, as

such laws are now in effect or as the same may at any time hereafter be amended.

## ARTICLE III.

The location and post office address of the registered office of this corporation in the State of Idaho is 2620 Warm Springs Avenue, Boise, Idaho.

#### ARTICLE IV.

The authorized capital stock of the corporation is the sum of Five Thousand Dollars (\$5,000.00) represented by One Hundred (100) shares of common, non-assessable stock of the par value of Fifty Dollars (\$50.00) each.
