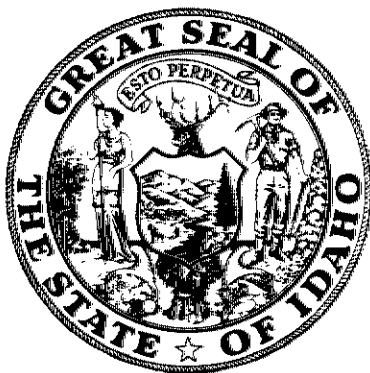

Jumping Jack's, Inc., a corporation of the State of Idaho, whose registered office is located at 117 14th Ave. So., Nampa, Idaho 83651, certifies pursuant to the provisions of Title 30 of the Idaho Business Corporation Act, as amended, that at a meeting of the stockholders of said corporation called for the purpose of amending the Articles of Incorporation, and held on October 27, 1985, it was resolved by the unanimous vote of the holders of 1,300 shares representing 100% of the outstanding common stock entitled to vote that Articles I & VI of the Articles of Incorporation are amended to read as follows:
