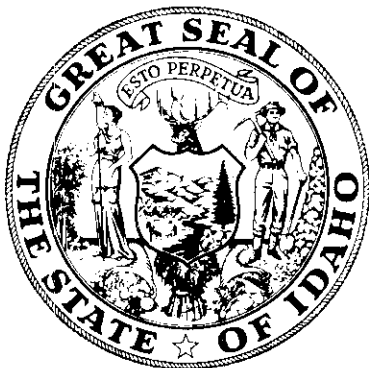

ARTICLES OF INCORPORATION
OF
MOUNTAIN VIEW PRODUCE, INC.

The undersigned, acting as incorporators, in order to form a corporation for the purposes hereinafter stated, pursuant to the Idaho Business Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be Mountain View Produce, Inc.

ARTICLE II

The purposes for which said corporation is formed are:

A. To engage in the business of buying and selling potatoes and other fresh produce including the operation of a fresh potato packing shed.

B. The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

The Corporation is to have perpetual existence.

ARTICLE IV

The address of the Corporation's initial registered office shall be Route 2, Box 158, Blackfoot, County of Bingham, State of Idaho and the name of its initial registered agent at such address is Hal Cramer.

ARTICLE V

The capital stock of the Corporation shall be one hundred (100) shares of common stock, without par value. The capital stock of the Corporation shall not be assessable.
