ARTICLES OF INCORPORATION  
OF  
LAKE COEUR D' ALENE PROTECTIVE ASSOCIATION, INC.

We, the undersigned citizens of the State of Idaho have this day voluntarily associated ourselves together for the purpose of forming a non-profit corporation under and pursuant to Title 30, Chapter 3, Idaho Code, and we do hereby certify:

ARTICLE I.

The name of this corporation is LAKE COEUR D'ALENE PROTECTIVE ASSOCIATION, INC.

ARTICLE II.

This corporation shall have perpetual duration.

ARTICLE III.

The purposes and objects for which this corporation is formed are the following:

1. To form a non-profit corporation for the protection and service of and to the individual members of the Association and to further their common interests.
2. To take all necessary actions to protect Everwell Bay and Lake Coeur d'Alene from degradation of water quality and destruction of aquatic life and to maintain and enhance the natural beauty and environment of waters and shoreline of Everwell Bay.
3. To take whatever action is necessary through state administrative agencies and the courts to protect and preserve Everwell Bay and to remedy, restore and mitigate any damage that has been caused by any persons or entities.

ARTICLE IV.

The corporation shall have the following powers:

1. To sue and be sued before competent tribunals at the will of the directors or membership.
2. To own, buy, sell, lease, assign, mortgage, hypothecate and by all lawful acts, deal in real and personal property, including the erection and maintenance of buildings and the obtaining of per-

sonal property which would further the interests of the corporation.

3. To establish bank accounts, charge dues and fees, solicit money, engage in non-profit enterprises, raise money, hire and fire employees, make loans, acquire loans, deal in choses of action, and engage in any enterprises connected to the purposes herein established in any lawful way, so long as the same are a non-profit nature.

4. To issue bonds, notes and other instruments of debt and to deal in the stocks, bonds, notes, mortgages and debt instruments of any other person, firm or corporation.

5. To join or merger with any other group, firm, association or corporation, non-profit in nature, whose purposes are not in conflict with those herein stated.

#### ARTICLE V.

This shall be a membership corporation. The membership fees and conditions shall be established by the By Laws.

#### ARTICLE VI.

The location and post office of the registered office of the corporation is Richard E. Fullwiler, 1025 Ironwood Drive, Coeur d'Alene, Idaho 83814.

#### ARTICLE VII.

The number of directors of this corporation shall be not less than three nor more than nine. The names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are as follows:


