Article 2: Purpose of Corporation:

- A. To engage in recreational motor sports, as espoused by the American Tractor Pulling Association (ATPA), and to follow the rules and guidelines laid down by the ATPA and/or this corporation.

- D. To buy, own, sell, assign, mortgage or lease any interest in personal property and real estate to construct, maintain and operate improvements thereon necessary or incidental to the accomplishment of the purposes set forth in Paragraph A.
- E. To borrow money and issue evidence of indebtedness in furtherance of any or all of the objects of its business, and to secure the same mortgage, pledge or other lien on the Corporation's property.
- F. To do and perform all acts reasonably necessary to accomplish the purposes of the corporation.
- G. This corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of section 501 (c ) (3) of the internal revenue code.
