Article 6: To the full extent permitted by law, no director shall be liable to the corporation or its shareholders for monetary damages for any action taken, or any failure to take any action, as a director of the corporation, except liability for:

- (i) The amount of a financial benefit received by a director to which he is not entitled;
- (ii) An intentional infliction of harm on the corporation or the shareholders;
- (iii) A violation of Idaho Code Section 30-1-833, or the corresponding section of any future Idaho Code;
- (iv) An intentional violation of criminal law.

Article 7: In furtherance and not in limitation of the indemnification powers conferred by the Idaho Business Corporation Act, and the objects and purposes set forth here, it is expressly provided that, to the full extent permitted by law, the corporation shall, and is hereby obligated to, indemnify any person, or the heirs, executors, or administrators of such person, who was or is a party or is threatened to be made a party to any threatened, pending, or completed action, suit, or proceeding, whether civil, criminal, administrative, or investigative, including, but not limited to, actions by or in right of the corporation, by reason of any action taken or failure to take any action as a director of the corporation, except liability for:

- (i) Receipt of a financial benefit to which he is not entitled;
- (ii) An intentional infliction of harm on the corporation or the shareholders;
- (iii) A violation of Idaho Code Section 30-1-833, or the corresponding section of any future Idaho Code;
- (iv) An intentional violation of criminal law.

Prior to making any indemnification, the corporation shall make, or cause to be made, such determinations or decisions, following such procedures or methods, as are required by law.

Article 8: The purpose of this corporation shall be to conduct customs brokerage business and any other lawful business.
