That we, the undersigned, being three natural persons of full age, have this day voluntarily associated ourselves for the purpose of forming a private corporation under the laws of the State of Idaho, and for that end hereby adopt articles of incorporation as follows:

ARTICLE I.

The name of the Corporation is Envirohealth, Inc., an Idaho Corporation.




ARTICLE VIII.






