In accordance with Idaho Code § 30-18-205, the undersigned Entities each herewith state:

**ARTICLE I. NAME, JURISDICTION AND TYPE OF THE NON-SURVIVING ENTITY.** The name of the Non-Surviving Entity is "Cobalt Truck Equipment, LLC". The Jurisdiction of organization of the Non-Surviving Entity is Washington. The Non-Surviving Entity is a limited liability company established by Articles of Organization filed in the offices of the Secretary of State of Washington on or about December 10, 2001.

**ARTICLE II. NAME, JURISDICTION AND TYPE OF THE SURVIVING ENTITY.** The name of the Surviving Entity is "Idaho Truck Specialties, L.L.C.".
