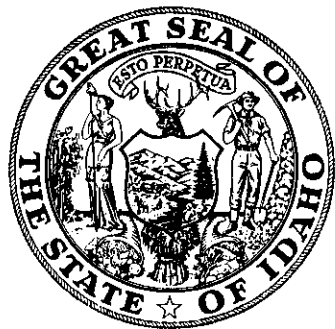
CERTIFICATE OF AMENDMENT OF

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is VILLAGE HOMES, INC.

SECOND: The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on April 14, 1994, in the manner prescribed by the Idaho Business Corporation Act:

Paragraph "First" of the Articles of Incorporation of Village Homes, Inc., is hereby amended to read as follows:

"First: The name of this corporation shall be Village Construction, Inc."

THIRD: The number of shares outstanding at the time of said amendment was 2,000, and the number of shares entitled to vote thereon was 2,000, all of which shares are common capital stock, each entitled to one (1) vote per share.

FOURTH: One Thousand (1,000) shares were voted for such amendment and zero (0) shares were voted against such amendment.


