The undersigned, each of whom are duly licensed to practice the profession of a Licensed Clinical Professional Counselor in the state of Idaho or any other state within the United States of America desire to form a Professional Services corporation pursuant to the Idaho business Corporation Action codified at Idaho code 30-1302, for the purpose of rendering general counseling services, and hereby adopt the following Articles of Incorporation:

Article 2, B to rent/own and operate offices throughout any state within the United States of America for the purposes of providing licensed clinical professional counseling services and other services associated therewith;

Article 2, F to do everything necessary, proper, or convenient for the accomplishment of any of the purposes herein set forth, and to do every other act incidental thereto which is not prohibited by laws of the state this corporation is operating within or by the provisions of these Articles of Incorporation.

The purposes of this corporation shall be carried out only through individuals who are duly licensed or otherwise legally qualified to render licensed clinical professional counseling services within the stat of Idaho or any other state within the United States of America, together with such employees as are deemed necessary to fulfill the purposes of operating a counseling profession.

Article 5 The aggregate number of shares which the corporation shall have authority to issue is Ten Thousand (10,000). The total authorized number of shares shall be without par value. The corporation is authorized to issue only one class of stock. Stock shall be issued only to persons who are licensed to practice counseling in the State of Idaho or any other state within the United States of America
