LET IT HEREBY BE KNOWN that the undersigned for the purpose of forming a corporation under the Idaho Business Corporations Act, Title 30, Chapter 1, IDAHO CODE does herein certify, declare and adopt the following ARTICLES OF INCORPORATION:

THE NAME of the Corporation shall be Ages Enterprises, Inc.

II.

THE NATURE of the business, or the object or purpose to be transacted, promoted, or carried on by the Corporation is:

- 1. To provide Perfusion services within the medical industry
- To transact any other lawful business purpose for which a corporation can be incorporated under the IDAHO BUSINESS CORPORATION ACT.

Ш.

THE AGGREGATE NUMBER of shares which the Corporation shall have the authority to issue is TEN THOUSAND (10000) shares of no par value common stock. Said shares shall constitute one class only.

IV.

THE CORPORATION is to have a perpetual existence.

THE BUSINESS of the Corporation shall be managed by its Board of Directors, each of whom shall be at least eighteen (18) years of age. The number of Directors of the Corporation shall be set forth in the Bylaws in a manner not prohibited by law. Until so changed, the number of Directors shall be one (1). The Directors need be neither stockholders of the Corporation, nor residents of the State of Idaho.

VI.

THE PRIVATE PROPERTY of the shareholders shall not be subject to the payment of Corporate debts.

VII.

THE CORPORATION SHALL have the authority, in accord with Idaho State Law, to indemnify each Director or Officer, or any person who may have served at its request as a Director, or Officer of another corporation in which it has shares of stock or of which it is a creditor, against actual and necessary expenses incurred by him in connection with the defense of any action, suit, or proceeding in which he is made a party by reason of being or having been a Director or Officer of the Corporation or of such other corporation (whether or not he continues to be a Director or Officer at the time of incurring such expense) except in relation to matters as to with the continue adjudged in such action, suit, or proceeding to be liable for CK: 7287 CI: 26668 PH: 784947
