To be done by the further purposes of this corporation to serve the public and organization its members, their families in leadership, and civic organizations as so far as their power and abilities.

(b) to carry out all purposes herein mentioned forth, their corporation shall have, and exercise all powers conferred by the law of the state of Idaho upon the corporations which are consistent with and permissible to organizations except as may violate the provisions of section 37(a)(3) of the National Small Business Act of 1950 and a violation of same.
