ARTICLE I.

The name of this corporation shall be McCall James Jones, Inc.

That Article III of the articles of incorporation be amended to read as follows:

ARTICLE III.

Section 1. (a) The purpose of this organization shall be civic service through the organized efforts of the youth of the community, to promote the welfare of the community and its citizens through civic, constructive projects. It shall be the further purpose of this organization to provide the youth with continuing its membership, training in leadership and civic education as to better their understanding of citizens.

(b) To carry out its purposes hereinafter set forth, this corporation shall have and exercise all powers conferred by the law of the State of Idaho upon like corporations which are consistent with and subservient to organizations exempt by law under the provisions of section 501(c)(4) of the Internal Revenue Code of 1954 and amendments thereto.
