ARTICLES OF INCORPORATION

OF

RELIABLE REBUILDERS, INC.

KHOW ALL MEN BY THESE PRESENTS: That we, the undersigned, each being of full age and all of whom are citizens of the United States, have this day voluntarily associated ourselves together for the purpose of forming a general business corporation under the Laws of the State of Idaho, and to that end do hereby adopt Articles of Incorporation as follows:

I

<u>NAME</u>

The name of this corporation shall be "RELIABLE REBUILDERS, INC."

ĪΙ

PURPOSES

The corporation shall have the following purposes:

- 1. To acquire by purchase, lease, or otherwise, and to equip, maintain and operate a general machine shop and foundry to do repairing, welding, brazing, soldering, polishing, molding, casting, pattern making, blacksmithing, metal stamping and cutting, electrical work, and general mechanical manufacture and repair.
- 2. To engage in the mercantile business, either wholesale or retail, to buy, sell, import, export, manufacture and deal in hardware, electrical equipment, plumbing supplies, farm equipment, machinery, road equipment, implements, supplies, tools, paints, engines, automobiles, tractors, gasoline, oils,

greases, fuel and auto and machine supplies of every class and nature.

- 3. To erect or cause to be erected on any lands owned, held or occupied by the corporation, buildings or other structures with their appurtenances and to rebuild, enlarge, alter or improve any buildings or other structures now or hereafter erected on any lands so owned, held, occupied, mortgaged or leased by the corporation.
- 4. To invest in real estate and to hold the same for rental and to generally deal in the rental of real and personal property of every kind and description; to buy, sell, own, lease, mortrage, hypothecate, encumber, convey, transfer, improve and maintain all forms of property, both real and personal.
- 5. To acquire and pay for in cash, stocks or bonds of this corporation, the good will rights, assets, stocks, bonds, and property of other corporations.
- 6. To engage in business as a partner or as a member of a joint venture with other persons, firms or corporations.
- 7. To guarantee contracts and obligations in which the company has or may have an interest, direct or indirect, make promissory notes, bills of exchange and other evidence of indebtedness; to borrow or to lend money on bonds, debentures, or otherwise to secure in such manner as it may be proper, the payment of any promissory notes, bonds, debentures or other evidences of indebtedness of the corporation, and to mortgage, pledge or to convey in trust any or all of its property, real,

personal or mixed, to secure the payment of any promissory notes, bonds, debentures or other evidence of indebtedness to the corporation.

- 8. To apply for and secure patents and copyrights, and the right to a trade name and trademarks, and to buy, sell, exchange and acquire patents, or any interest therein, in any country, except enemy countries, and to permit the manufacture and sale of patented articles on payment of royalties, and to pay royalties and to manufacture and sell articles patented by others.
- To guarantee the payment of obligations of this or any other company whenever, in the judgment of the Board of Directors, considered proper or necessary for the business of the company.
- 10. To carry on all or any of its operations and business without restriction or limit, and to carry out the objects and purposes of this corporation in any of the states, districts, territories or colonies of the United States, and in any and all foreign countries, subject to the laws of such state, district, territory, colony or country.
- 11. In general, to carry on any other business in connection with the foregoing, and to have and to exercise all the powers conferred by the Laws of the State of Idaho upon such corporations, and to do any and all of the things hereinbefore set forth to the same extent as natural persons might or could do.
 - 12. The foregoing clauses shall be construed both as

objects and powers; and it is hereby specifically provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the powers of this corporation.

DURATION

This corporation shall continue perpetually.

II

REGISTERED OFFICE

The principal place of business of the corporation shall be Moscow, Idaho, with 1014 South Jefferson as the address of its registered office.

V

CAPITALIZATION

The total authorized capital stock of this corporation shall consist of 200 shares of no par value, non-assessable, voting common stock, and each share shall be in all respects equal to every other share.
