

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act the undersigned corporation adopts the following Articles of Amendment to the Articles of Incorporation:

1. The name of the corporation is GREEN LINE SALES INC.

2. The following amendments of the Articles of Incorporation by the shareholders of the corporation on September 30, 1991, in one of the manners prescribed by the Idaho Business Corporation Act, namely, the consent of all of the shareholders, to-wit:

"3. PURPOSES: The purpose or purposes for which the corporation is organized to manufacture, install, purchase, sell, and trade in farming and agricultural machinery, tools, apparatus, equipment and supplies of all kinds and to purchase, sell, and trade in consumer products, equipment, supplies and merchandise, and otherwise to transact any and all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.


