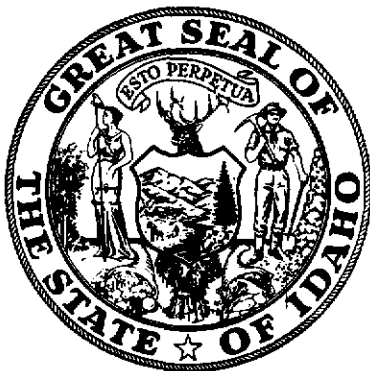

AMENDMENT TO ARTICLES OF INCORPORATION

1. The name of this Corporation is Paramount Supply Company, Inc. and its mailing address is P.O. Box 50097, Idaho Falls, Idaho 83404.

2. Article V of the original Articles of Incorporation is amended to read:

"The total number of shares which may be issued by the Corporation is 2000, of no par value."

3. The Board of Directors approved this Amendment on the 20th day of January, 1989 and submitted the same to the Shareholders at a Special Meeting held on the 6th day of June, 1989. The Shareholders and the Members of the Board of Directors unanimously approved the change.

4. There are presently 100 shares of stock of the Corporation outstanding, the owners of all of which voted for the amendment.

5. It is intended that the present stock certificates be cancelled and new certificates be issued to the same Shareholders for 20 shares in exchange for each 1 share surrendered to the company.

6. Except for the designated amendment to Article V, the original Articles of Incorporation remain unchanged. The original Articles of Incorporation, together with the restated Article V, supersede the original Articles of Incorporation.

7. This amendment does not affect or change in the amount of stated capital.


