The undersigned, being the sole directors of SANDPOINT TRAILER SUPPLY, INC., to hereby adopt the following Articles of Amendment to the Articles of Incorporation of Sandpoint Trailer Supply, Inc. as provided by I.C. §30-1-58 et seq.

I.

The name of this corporation was previously SANDPOINT TRAILER SUPPLY, INC., but by these Articles of Amendment is hereby changed to SANDPOINT TRAILER R.V. CENTER, INC.

II.

The amendment of the original Articles of Incorporation of Sandpoint Trailer Supply, Inc., dated March 7, 1983, and filed March 11, 1983, made by these Articles of Amendment is to amend the name of said corporation from SANDPOINT TRAILER SUPPLY, INC. to SANDPOINT TRAILER R.V. CENTER, INC.
