

ARTICLES OF INCORPORATION
of the
CROWN POINT GOLD MINING COMPANY.

The undersigned, for the purpose of forming a corporation under the Laws of the State of Idaho, do hereby associate, declare and agree as follows:

Article I.

The name of this Corporation is the Crown-Point Gold Mining Company, Limited.

Article II.

The purposes for which it is formed are to lease, acquire, purchase and hold real and personal property; to issue and execute leases, options, bonds and conveyances of its property; to issue bonds, mortgages and trust deeds; to develop, work and operate mines and mining claims; to acquire, erect and purchase and operate mills, smelters, sampling and other works for the proper treatment of ores; to acquire, erect and purchase water rights and privileges; to acquire, erect and purchase and operate power and electric plants and generally to conduct a general development business.

Article III.

The place where its principal business is to be transacted shall be Mountainhome, Elmore County, Idaho, but such branch offices may be, by the directors, established as shall be deemed necessary.

Article IV.

The term for which it is to exist is fifty years from and after twelve o'clock, noon, of the date of its incorporation.

The number of its directors shall be five, and the names and residences of those appointed for the first year are:

The amount of the capital stock of this Corporation shall be ONE MILLION DOLLARS, divided into FIVE HUNDRED THOUSAND shares of the par value of TWO DOLLARS each.
