ARTICLES OF INCORPORATION

We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators of a corporation under the Utah Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is BEEHIVE PIZZA, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: To operate retail pizza stores.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is Fifty Thousand (50,000) of the par value of One Dollar (\$1.00) each.

FIFTH: The corporation will not commence business until consideration of the value of at least \$1,000 has been received for the issuance of shares.

SIXTH: Provisions limiting or denying to shareholders the preemptive right to acquire additional or treasury shares of the corporation are: No holder of any shares of any class of stock of the corporation shall be entitled, as such, as a matter of right, to subscribe for or purchase or receive any part of any unissued stock of any class of the corporation, or of any stock of any class issued and thereafter acquired by the corporation, whether now authorized or hereafter created, or of any securities

of any kind convertible into or evidencing the right to subscribe for or purchase or receive any stock of any class of the corporation, whether now authorized or hereafter created, and in either case, whether issued for cash, property, services or any other consideration.

SEVENTH: The post office address of its initial registered office is 175 South Main Street, c/o C T Corporation System, Salt Lake City 11, Utah, 84111, and the name of its initial registered agent at such address is C T CORPORATION SYSTEM.
