## ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, that I, the undersigned of the United States, in order to form a corporation for the purposes hereinafter stated, pursuant to the Business Corporation Act of Idaho, do hereby certify that:

FIRST: The name of the Corporation is Northwest Roofing, Inc.

SECOND: The purpose for which said corporation is formed is: to engage in construction roofing and any other lawful purpose.
