1. NAME

The name of this corporation is Boys and Girls Clubs of Ada County, Inc.

2. PURPOSE

This corporation is organized to provide behavior guidance and to promote the health, social, educational, vocational and character development of boys and girls, without regard for race, color, creed or national origin; to operate one or more Club sites for program activities and services. It may pursue those goals by transaction of any lawful business as described in the Idaho Nonprofit Corporation Act. The corporation will operate for educational purposes as defined by the U.S. Internal Revenue Code, Section 501(c)(3).

6. MEMBERSHIP

The corporation will have corporate and individual memberships.

7. DISTRIBUTION OF ASSETS ON DISSOLUTION

Assets remaining upon dissolution of the corporation shall be distributed to a nonprofit fund, selected by the Directors, which has established its tax exempt status under Sec. 501(c)(3) of the IRS Code.
