This company shall be capitalized for \$100,000. The total authorized stock of this corporation shall be divided into 100,000 shares, all of which shall be common stock with a par value of \$1.00 per share. Said shares shall be non-assessable and shall be of the same class and every share of said stock shall be equal in all respects to every other of said shares, and there shall be no preemptive rights.

The said shares may be issued and sold from time to time by the corporation for such consideration and upon such terms as may, from time to time, be fixed by the Board of Directors without action by the stockholders.

Pursuant to the provisions of Section 30-1-630, <u>Idaho Code</u>, the Board of Directors of this corporation shall have power and authority from time to time to authorize the sale of, and to sell for cash or otherwise, all or any portion of the unissued and/or of the treasury stock of this corporation without said stock, or any thereof, being first offered to the shareholders of this corporation. The shareholders of this corporation shall not have preemptive rights.

ARTICLE VI.

The corporate powers of this corporation shall be vested in a Board of Directors of not less than one (1) and no more than five (5) members, who shall be elected annually by the shareholders, and who shall serve until the election and qualification of their successors. A Director of this corporation need not be a shareholder therein. Directors who are to serve for the first corporation year shall be selected by the incorporator. Unless otherwise determined by the shareholders, the

Board of Directors by resolution, shall from time to time fix the number of directors within the limit herein provided. Lisa T. Weinschel shall constitute the initial Board.
