Wourms and Michael Steffans, residents of the County of Shoshone, State of Idaho, and Samuel Seidenfeld, a resident of the City of Spokane, County of Spokane, State of Washington, all of whom are citizens of the United States of America, a majority of whom are freeholders of the State of Idaho, have this day associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and WE DO HEREBY CERTIFY:

I.

That the name of this corporation is and shall be "THE CLEARWATER GOLD AND COPPER MINING COMPANY, Limited".

II.

That the purpose for which the said corporation is organized is to purchase, locate, lease or otherwise acquire, mines, mining claims, mining rights, water rights and lands, and any interest therein, and to explore, work, exercise, develop and turn to account the same; to quarry, mine, smelt, refine, dress, amalgamate and prepare for market, ore, metal and mineral substances of all kinds, and to carry on any other operations or business which may seem necessary, convenient or incidental to any of the objects of the company; to buy, sell, manufacture and deal in minerals, plants, machinery, implements, conveniences, provisions and things capable of being used in connection with the mining and other operations of this corporation, or required by workmen and others employed by the Company; to construct, carry out, maintain, improve, manage, work, control and superintend any roads, ways, railways, bridges,
