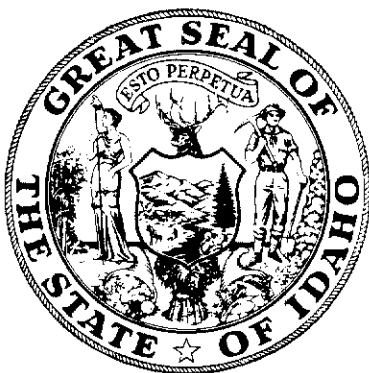

ARTICLES OF AMENDMENT TO THE ARTICLES

OF INCORPORATION OF

INNOVATIVE INVESTMENTS, INC.

1988 2 27 9 04

Pursuant to the provisions of Idaho Code Section 30-1-59, et. seq., the undersigned corporation adopts the following Articles of Amendment to its existing Articles of Incorporation. All outstanding shares were entitled to one vote per share. The Amendment to Articles has been voted upon and approved by 100% of all shareholders of all outstanding shares. The date of adoption of the amendment is April 15, 1988.

After voting on the amendment by all shareholders of record, it was determined to cancel all outstanding shares and re-issue shares after amendment. The authorized number of shares has been changed and all outstanding shares have been cancelled.

The following sections of the previously filed Articles of Incorporation shall be modified as follows:

A. The name of the corporation shall be changed from Innovative Investments, Inc. to Innovations, Inc.

B. Article I shall be changed to read:

The name of the corporation shall be:

Innovations, Inc.

C. Article IV. Section 2. Number of Shares. The aggregate number of shares which this corporation shall have authority to issue is twenty-two (22) shares with no par value.

D. All other provisions of the original Articles of Incorporation shall remain the same.
