ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That pursuant to the provisions of Idaho Code Section 30-146, Silver Beach Development, Inc., an Idaho corporation, by and with the written consent of all of its shareholders has reduced its capital stock from \$250,000.00 to \$25,000.00 and to that extent amends Article V of its Articles of Incorporation as follows:

11 V

That the authorized capital stock of this corporation shall be \$25,000.00 divided into 25,000 shares of a par value of \$1.00 each, and that the total authorized number of shares shall be 25,000 and their total par value shall be \$25,000.00. No share of stock of this corporation when issued and fully paid for shall be subject to assessment."
