perpetual existence from the date hereof, with its registered office in this State located at

and as such are subject to the rights, privileges and limitations granted to Non-Profit Coopera-
tive Associations as provided in Chapter 10, Title 30, Idaho Code.

ARTICLES OF INCORPORATION
OF
KAMIAH CHAMBER OF COMMERCE, INCORPORATED

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, citizens of the United States, and residents of Kamiah, Lewis County, Idaho, do hereby associate ourselves together to form a non-profit corporation, and in order to form a corporation for the purposes hereinafter stated under the provisions of Chapter 10 of Article 30, Idaho Code, and the laws of the State of Idaho relating to the organization of corporations where pecuniary profit is not the object, do hereby CERTIFY AND DECLARE as follows:

I.

The name of this corporation is, KAMIAH CHAMBER OF COMMERCE, INCORPORATED.

II.

The purposes and objects for which the corporation is formed are, without pecuniary profit, to promote, conduct, provide for and carry on any and all activities to stimulate the growth and general welfare of the City of Kamiah and its surrounding area; to hold title to all property which said Chamber may now own or may hereafter acquire, and for said purposes and to that end to buy, sell, acquire, own, mortgage, hypothecate, transfer, lease, exchange, trade or otherwise acquire or dispose of, real and personal property and otherwise do all acts and things necessary or convenient in or about the conduct, management and carrying on of such activities, objects and purposes, and to make, perform and carry out contracts and agreements for any lawful purpose, to the same extent and as fully as natural persons might or could do, and to do, perform and carry on its business as principal, agent, trustee or otherwise, and either alone or in conjunction with any other person, firm, association, corporation and with agencies, departments and officers of the State and Federal Government.

III.

This corporation shall have perpetual existence.

IV.

The location and post office address of the registered office of the corporation is: Kamiah, Lewis County, Idaho.

V.

This corporation is not organized for pecuniary profit and it shall not have or issue any capital stock. Membership in the corporation shall not entitle a person to any interest whatsoever in the assets of the corporation, but only to participate in the management of the affairs of the corporation, in meetings of the members legally called and held within the period covered by the membership. **The rights and interests of all members shall be equal.**

VI.

The members of this corporation shall not be subject to assessments for the purpose of paying expenses, conducting business, or paying debts of the corporation.

VII.

The number of directors of the corporation shall be as specified in the By-laws, and such number from time to time may be increased or decreased in such manner as may be prescribed in the By-laws. In case of an increase in the number of directors, the additional directors may be elected by the directors then in office, and a director so elected shall hold office until the next annual meeting of the members, and until his successor is elected and qualified.

VIII.

Each member in good standing of the Kamiah Chamber of Commerce, Lewis County, Idaho, shall be and continue to be a member of this corporation so long as such member continues to be in good standing as a member of said Chamber. The official membership card issued by said Chamber each year to its members shall be the certificate of membership in this corporation. Such membership in this corporation shall always be unassignable.
