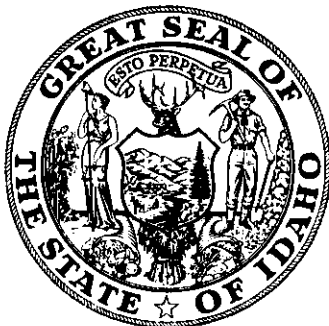

RESTATED ARTICLES OF INCORPORATION  
OF  
WESTERN COMMUNITY INSURANCE COMPANY

ARTICLE I

CORPORATE NAME

The name of this corporation is Western Community Insurance Company.

ARTICLE II

DURATION

This corporation shall have perpetual existence.

ARTICLE III

PURPOSES

The purposes for which this corporation is organized are:

1. To conduct a multiple-line insurance business as defined from time to time by Idaho law.
2. To engage in the business of providing property insurance and other related hazards insurance, marine and transportation insurance, disability insurance, surety insurance, worker's compensation insurance, and casualty insurance, all as defined from time to time by the laws of the State of Idaho.
3. To engage in the business of reinsuring any risk which this company is authorized to write and to reinsure its own risks with other companies.
4. To engage in any other lawful business or activity whatsoever which may be authorized at any time by the Board of Directors; and in furtherance thereof this corporation shall have all of the powers granted by law to corporations generally.

ARTICLE IV

OTHER JURISDICTION

The corporation may carry out its purposes and exercise its powers in any state, territory, district, or possession of the United States, or in any foreign country, to the

extent that these purposes and powers are not forbidden by the law of the state, territory, district, or possession of the United States, or by the foreign country; and it may limit the purpose or purposes that it proposes to carry out or the powers it proposes to exercise in any application to do business in any state, territory, district, or possession of the United States or foreign country.

#### ARTICLE V

##### REGISTERED OFFICE AND AGENT

The address of the registered office of the corporation is 1001 North 7th, Centennial Plaza, Pocatello, Idaho 83205, and the name of the registered agent at such address is Ronald E. Melton.

#### ARTICLE VI

##### Common Shares

The total number of authorized common shares of the corporation is One Hundred Fifty Thousand (150,000) shares of the par value of Twenty Dollars (\$20.00) per share amounting in the aggregate to Three Million Dollars (\$3,000,000). The common shares of the corporation shall be non-assessable.

#### ARTICLE VII

##### PREEMPTIVE RIGHTS

The shareholders of the corporation shall not have preemptive rights to acquire additional shares issued by the corporation.

#### ARTICLE VIII

##### DIRECTORS

The initial directors of the corporation shall be fifteen in number. The names and addresses of the first directors are as follows:

##### VOTING

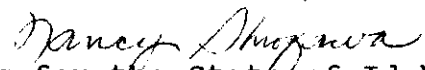

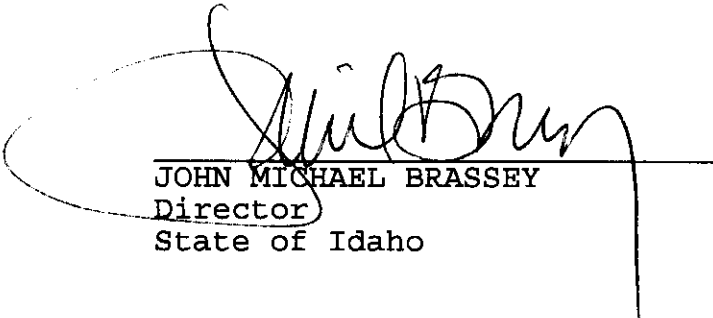
