## ARTICLES OF INCORPORATION

Know All Men By These Present That We, the undersigned being natural persons of full age and citizens of the United States of America and residents of the State of Idaho, in order to form a comporation for the purposes bereinafter states pursuant to the laws of the State of Idaho, do hereby certify as follows.

T

The name of the corporation shall be and is Idaho Field Archery Association, Incorporated.

II

The duration of the corporation is perpetual.

III

The purposes for which the corporation is organized are:
To purchase hold or lease any quantity of hand, with such buildings
and improvements as maybe erected thereon, as may be needed or
necessary for the maintenance and operation of an archery field range.

To promote, encourage and advance field archery and how hunting, and participation therein by the people of the State of Idaho.

To contract such debts as maybe necessary in the due course of the corporation activities.

To accept as members all persons interacted in the advancing of the cause of field archery and bow hunting.

To issue membership certificates to each member thereof, which certificates cannot cause under any circumstances any member to have or acquire a greater interest therein than any other member.

In general to carry on any lawful business whetcomer, in commettion with the foregoing which is needed or necessary to carry on any or all portions of the foregoing.
