
KNOW ALL MEN BY THESE PRESENTS: That at a special meeting held on 9th day of March, 1993, at Mountain Home, Idaho, pursuant to notice of meeting being given as provided by Section 30-310, Idaho Code, the following Resolution was unanimously adopted by vote of approval of two-thirds of the members of the corporation as follows, to-wit:


BE IT RESOLVED, that the Articles of Incorporation of LIVING GRACE FELLOWSHIP, INC., be and the same are hereby amended and modified as follows, to-wit:

ARTICLE I
