ARTICLE I.

Name

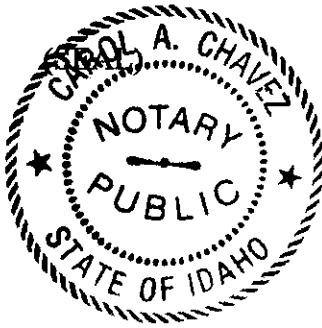
