

ARTICLES OF INCORPORATION OF DRAGON'S LAIR, INC.

The undersigned incorporators, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopts the following articles of incorporation:

ARTICLE ONE NAME

The name of the corporation is DRAGON'S LAIR, INC.

ARTICLE TWO PURPOSES

The purpose of the corporation is to engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act including, but not limited to, the breeding, raising, selling, import, export and training of livestock; the general livestock and ranching business; to establish, purchase, lease or acquire, own, operate, maintain, sell, morgtgage, or otherwise dispose of retail or wholesale items of every kind and nature, and of real property; to manufacture, produce or reproduce, duplicate, fabricate, products, designs, systems, and all items related to the entertainment, electronic, or computer sciences; and to export and import to and from any foreign country, merchandise of every kind and nature.

ARTICLE THREE DURATION

The period of duration of the corporation is perpetual.

ARTICLE FOUR REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE FIVE STOCK

The amount of the total authorized captital stock of this corporation is one hundred (100) shares of common stock without nominal or par value, and which shall be all of the same class. Such stock may be issued from time to time for such consideration as may be fixed from time to time by the board of directors and
