KNOW ALL BY THESE PRESENTS:

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

I.

The name of the corporation is APEX REALTY, INC.

II.

The period of its duration is perpetual.

III.

The purpose or purposes for which the corporation is organized are:

To carry on and conduct the business of a real estate agent or broker, and in behalf of others, to buy, sell, deal in, lease, rent, and manage real estate and any interests therein.

To purchase, improve, develop, lease, exchange, sell, dispose of, and otherwise deal in and turn to account, real estate; to purchase, lease, build, construct, erect, occupy, and manage buildings of every kind and character whatsoever; to finance the purchase, improvement, development and construction of land and buildings belonging to or to be acquired by this corporation, or any other person, firm, or corporation.

To transact the business of investing on behalf of itself or others; to provide financial counseling; to generally deal in investments; to provide the service of estate planning and related counseling; and

To conduct and transact any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
