

Articles of Incorporation of The Robb Mercantile Company,
Limited.

Know all men by these presents: That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho.

And we hereby certify;

First: That the name of the said corporation is, The Robb Mercantile Company, Limited.

Second: That the purposes for which it is formed are to carry on a general wholesale and retail mercantile business, near the town of Roosevelt, in the County of Idaho, and State of Idaho, and to do all things in and about the carrying on of said wholesale and retail mercantile business; to buy and sell goods either at wholesale or retail, or upon commission, or consignment, and to mortgage its said property; to own real estate in connection with said business.

Third: That the place where its principal business is to be transacted shall be near the town of Roosevelt, (at a place now called Sannyside) in the County of Idaho, State of Idaho.

Fourth: That the term for which it is to exist is twenty five years from and after the date of its incorporation.

Fifth: That the number of its directors shall be five, and the names and residences of those who are appointed for the first year are:

Sixth: That the amount of the capital stock of this corporation shall be Twenty Four Thousand Dollars, divided into twenty four thousand shares of the par value of one dollar each.
