KNOW ALL MEN BY THESE PRESENTS that the undersigned, all being of full age and citizens of the United States and residents of the State of Idaho, have this day voluntarily associated ourselves for the purpose of forming a non-profit charitable corporation under Title 30, Chapter 3, Idaho Code, and we certify as follows:

ARTICLE I

The name of the corporation shall be SOUTH CENTRAL IDAHO CATHOLIC SOCIAL SERVICES, INC.

ARTICLE II

The corporation shall be a non-profit corporation.

ARTICLE III

The period of existence of this corporation shall be perpetual.

ARTICLE IV

This corporation is formed for the exclusive purpose and object of aiding the deserving poor, deprived and underprivileged by spiritual and material assistance adapted to the particular needs of such persons and generally to perform such works of charity as may be feasible and practicable from time to time, including, for such purposes, the making of distributions to such organizations that qualify as tax exempt organizations under Section 501(c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue

law). The object and purposes of this corporation are limited to activities and undertakings allowed to tax exempt organizations under the aforementioned section of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue law) .

ARTICLE V

This corporation shall not have capital stock, but shall issue membership certificates. Membership shall be limited to those persons who are the duly appointed and acting pastors of the Catholic Parishes in Twin Falls, Lincoln, Gooding, Blaine, Cassia, Minidoka and Jerome Counties, Idaho, who elect to become members. The rights and interests of all members shall be equal and no member can have or acquire a greater interest than any other member.

ARTICLE VI

The street address of the initial registered office of the corporation is 1031 Eastland Drive, Suite 1B , Twin Falls, Idaho, 83301, and the name of the initial registered agent is John A. Doerr.

ARTICLE VII

The officers of the corporation shall be managed by a Board of Directors, the initial Board consisting of three members whose names and addresses are as follows:

who shall hold office until the first annual election of directors. The number of directors thereafter, the manner of election and qualification shall be published in the By-Laws. The Board of Directors shall have the authority to elect such officers as are required and/or allowed by law with the duties of such officers to be established by the By-Laws.

ARTICLE IX

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to

make payments and distributions in furtherance of the purposes set forth in Article IV above. No substantial part of the activities of this corporation shall be or involve the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

ARTICLE X

Upon the dissolution of this corporation, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of this corporation, dispose of all of the assets of this corporation exclusively for the purposes of this corporation in such manner, or to such organization or organizations and operating exclusively for charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue law), as said Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the State of Idaho District Court of the county in which the principal office of this corporation is then located, exclusively for such purposes or as to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

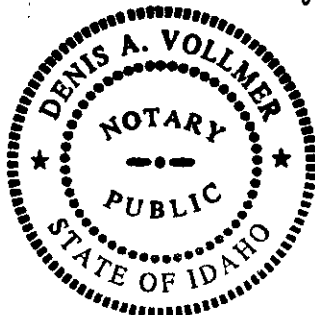

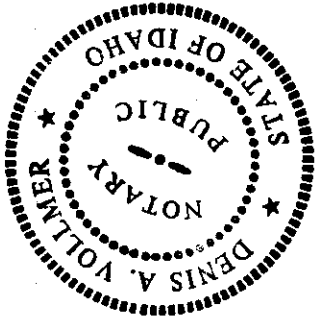

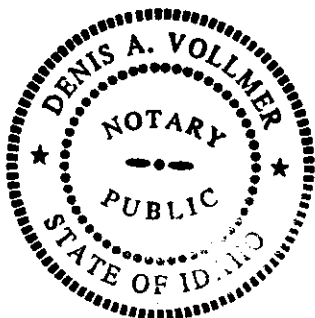
