ARTICLES OF INCORPORATION OF STATE

OF

PRIEST LAKE VOLUNTEER FIRE ASSOCIATION. INC.

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Business Corporation Act, Chapter 3, Nonprofit Corporations, adopts the following Articles of Incorporation for such corporation:

VOLUNTEER FIRE ASSOCIATION, INC.

SECOND: The corporation is a nonprofit corporation.

THIRD: The period of its duration is perpetual.

FOURTH: The purpose for which this corporation is formed shall be and is to act as a volunteer fire department, to respond to, eliminate, contain, douse, fight, enclose, battle, resist, put out, extinquish, quench, snuff out, blow out, stamp out and smother all residential and commercial building fires at Priest Lake, Idaho, including, but not limited to, the area from Outlet Bay to Indian Rock. And to that end, to acquire, maintain, operate, construct, purchase and obtain fire equipment, supplies, hoses, pumps, vehicles and other items, and to that end to enter into contracts to borrow money, and to make and negotiate note, contracts, bonds or mortgages, as evidence of, and security

for money borrowed or loaned, and for the purpose of perpetuating and carrying out the purposes for which this corporation is formed, to buy, lease or otherwise acquire all real and personal property necessary for such purposes, including stock in other corporations as directed by the By-Laws.

FIFTH: The address of the initial registered office of the corporation is c/o Route 5 Box 203, Priest Lake, Idaho 83856.

SIXTH: The name of its original registered agent is Kenneth Meppen at such address.

SEVENTH: Voting shall be based upon a one (1) vote per member or shareholder basis.

EIGHT: The number of directors of the corporation shall be three (3), the minimum provided by Idaho Code §30-315.
