

## Articles of Incorporation

Freedom Center Incorporation. We the undersigned, for the purpose of forming a non-profit corporation, under and pursuant to Title 30, Chapter 3, Section 323, of Corporation Laws of the State of Idaho, 1979, and amendments thereof, do hereby associate ourselves, as a non-profit organization, and do hereby adopt the following Articles of Incorporation.

### ARTICLE 1

The name of the corporation shall be, Freedom Center, ~~Incorporation~~,  
INCORPORATED.

### ARTICLE 2

REV. GA WING CH'EN.  
6-22-83.

The purpose of this corporation shall be to provide free counseling to persons, with alcohol and/or drug abuse related problems, runaways, suicides, rapes, marital problems, and etc, not providing or practicing medicine or professional counseling.

For the accomplishments of this purpose, the organization will accept donations of capital, goods, services, and/ or property.

At its discretion it may also deem it appropriate to hold fund raising activities, and may perform such further acts as are necessary and convenient to capitalize, and maintain its interests and property.

All acts being not contrary to law.

### ARTICLE 3

Existence of the corporation shall be perpetual.

### ARTICLE 4

The principle place of business shall be in Osburn, 1301 Yellowstone, Shoshone County, Polaris, Idaho; But shall not be restricted to that county, city, or state.
