ARTICLES OF INCORPORATION

of

WESTVIEW WATER CORPORATION, INC.

KNOW ALL MEN BY THESE PRESENTS:

THAT WE, the undersigned, being each full age citizens of the United States of America, and of the State of Idaho, do hereby certify that we have associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, pertaining thereto, to-wit: 30-301, et.sec., and hereby adopt the following ARTICLES OF CORPORATION:

ARTICLE I

The name of this corporation shall be WESTVIEW WATER CORPORATION, INC.

ARTICLE II

The duration of this Corporation shall be perpetual.

ARTICLE III

The object and purposes of this Corporation shall be and are as follows:

- (a) To operate as a non-profit corporation as defined by the laws of the State of Idaho.
- (b) To operate and maintain a community well for the benefit of the members of this corporation.

ARTICLE IV

This corporation shall have certificates of membership issued to members hereof and the management of its affairs shall be bested in its members pursuant to Idaho Code Section 30-314(c). The entire membership shall constitute the membership of the Board of Directors of this corporation,

and each member shall automatically be on the Board of Directors upon receiving membership in the corporation. Each membership certificate shall entitle the holder thereof to one vote in the affairs of the corporation and one person may hold more than one membership herein.
